### AMENDMENT OF TRUST DEED

NO This Deed of Amendment of SHRI. USK RURAL EDUCATION AND DEVELOPMENT TRUST(R) is made and executed on this **19<sup>th</sup> day of July 2022**

By

**SHRI PRATHAP HEGDE**, aged about 40 years son of Shekhar Hegde, residing at, Nalkur Post and Village, Brahmavara Taluk and Udupi District (Hereinafter referred to as "FOUNDER TRUSTEE").

WHEREAS on 08-01-2016 the founder trustee Shekhara Shetty aged about 76 years S/o Bacha Shetty residing at Mudduru Chagatekatte Nalkur Post and Village, Brahmavara Taluk and Udupi District along with another foundr Trustee namely Sri.Dinesh Muddur Shetty, aged about 46 years, son of V.Shekar Shetty, resident of Sri. Kruishna Sheshadri, Birlabettu, Kenjoor Post and Village of Udupi Taluk and District have jointly declared, constituted and established a Trust in the name of SHRI.USK RURAL EDUCATION AND DEVELPOMENT TRUST (R).by way of registered Trust Deed dated 08-01-2016 bearing No. BHV-4-00073/2015-16 in C.D.No. BHVD 234 4/1995-96 of IV Book of S.R.O Brahmavara. The said original trust comprised of two founder trustees. That by virtue the said deed of Trust, the founder trustees have granted transferred and assured unto a sum of Rs.15,000/- towards Trust fund to gave and hold the same for the objects of the trust for which it was created.

AND WHEREAS one of the founder trustee Mr. Sri. Dinesh Muddur Shetty has voluntarily resigned from the post of trusteeship due to his personal inconvenience by giving his resignation letter dated:02-06-2017. And whereas by invoking the power conferred clause 5.2 of the above trust deed that the said resignation was accepted in the Board Meeting held on 03-07-2017 and a resolution to the said effect was passed in the Board as per R.No:1 and 2. In view of the acceptance of the resignation of said founder trustee, the Board by majority decision decided to amend the original trust deed so the amendment as been carried out on 07-08-2018 in Doc No.BHV-4-00034/2018-19 in CD Number BHVD 284 of Book number 4 before SRO Brahmavar.

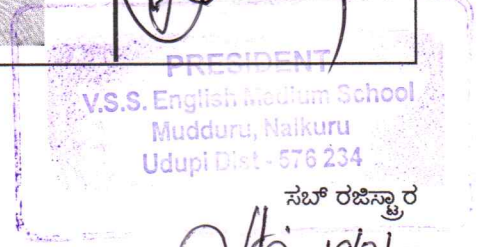

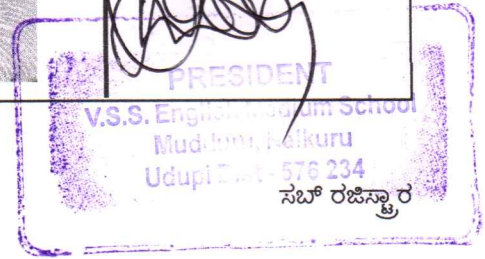

And whereas by invoking the power conferred clause 5.2 of the above trust deed that the said resignation was accepted in the Board Meeting held on **13-06-2022** and a resolution to the said effect was passed in the Board as per R.No:1 and 2.

AND WHEREAS In a meeting held on **17-06-2022** all the trustees have unanimously selected **SHRI PRATHAP HEGDE** as the president of SHRI. USK RURAL EDUCATION AND DEVELOPMENT TRUST(R) decided to amend the Trust deed to that effect. Hence this deed of amendment is made and executed as follows:

### DETAILS OF AMENDMENTS OF ORIGINAL TRUST

- 1) It is hereby declared that the name of the FOUNDER TRUSTEE Sri. Shekhara Shetty aged about 76 years S/o Bacha Shetty residing at Mudduru Chagatekatte Nalkur Post and Village, Brahmavara Taluk and Udupi District to be deleted from the original Trust deed in view of his voluntary resignation for all purpose and intents the Trust of SHRI, USK RURAL EDUCATION AND DEVELOPMENT TRUST (R). That all the claims, liability and assets of the resigned trustees has been dissolved by the Board of Trustee and hereinafter the said founder trustee has no manner of right, title and interest in any of the affairs, purpose, object,

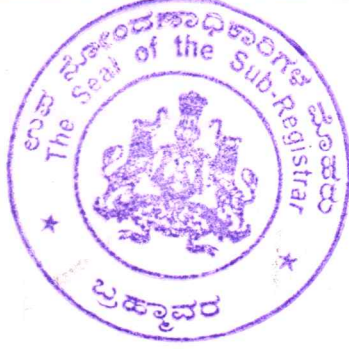
